Corporate Membership Information:

Corporate Membership shall be open to any business entity (corporation, partnership, sole proprietorship etc.). Fees payable by Corporate Membership shall be 150% of the Senior Membership Initiation Fees and Annual Dues. Corporate Membership shall have the right to designate up to three corporate representations who will be issued membership cards, which shall be valid so long as the Corporate Membership is in good standing. Corporate Membership representatives shall not have the right to vote or hold office but may serve on Club committees and volunteer.

All members are encouraged to help out with the running of the Club. In order to keep our fees to a minimum we ask that members pitch in and help with organizing and running the events, races, and programs the Club offers. And, of course, we're always pleased to have members lend a hand keeping the Clubhouse, the grounds and the dock in shipshape condition!

Procedure:
